

# Praying for the Supreme Court


Dobbs v. Jackson Women's Health Organization will be heard before the Supreme Court on December 1, 2021. The Mississippi law in question prohibits abortions after fifteen weeks except in case of medical emergencies and fetal abnormalities.



**Pray for the key people who are determining the outcome of this important case.** Each of the nine justices of the Supreme Court has four law clerks who assist them. These brilliant law graduates have usually clerked for other federal judges. They may influence how the justices will vote in cases.

Below each Justice is the name and information of each clerk, with law school graduation date and other judges they have clerked for listed.

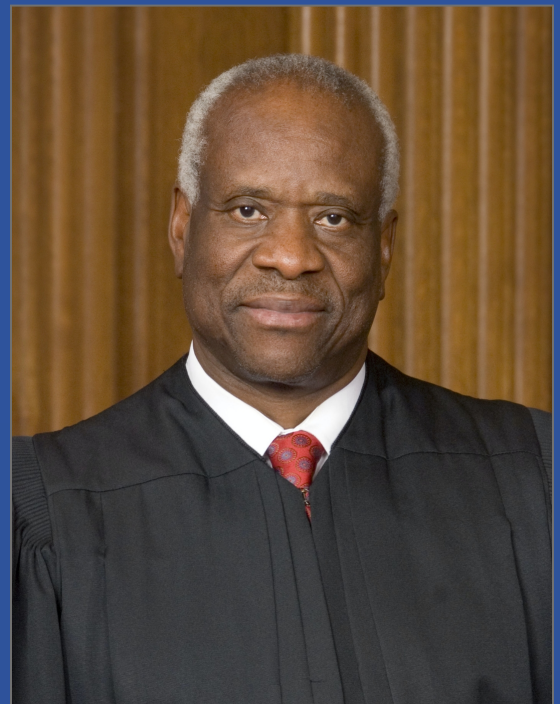

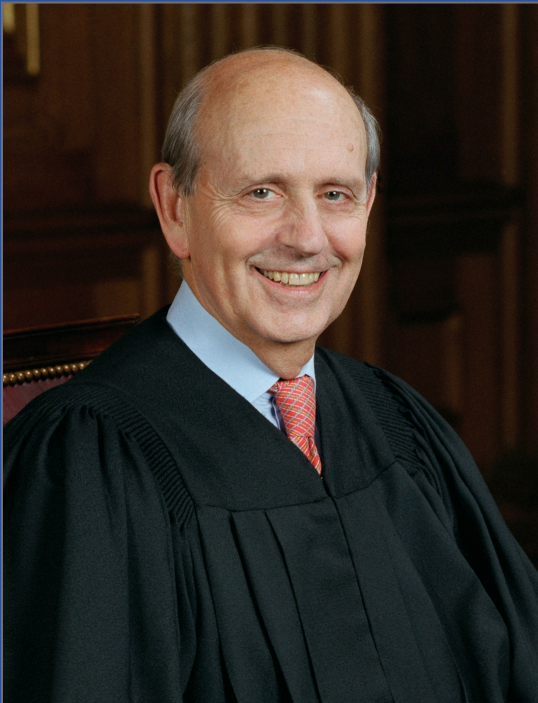

## Praying for the Nine Justices of the Supreme Court

**Pray for the court to execute righteous  
and fair judgment based on the fear of  
the Lord and not fear of men.**

*These are the things you should do: Speak the truth to one another. In the courts give real justice—the kind that brings peace. (Zech 8:16)*

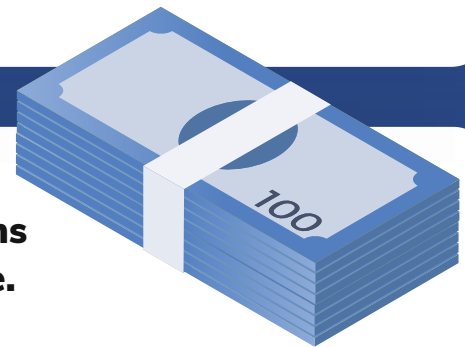
*The God of Israel said, the Rock of Israel spoke to me, He that rules over men must be just, ruling in the fear of God.” (2 Sam 23:3)*



**Pray for the heart of each justice to encounter Jesus Christ as Lord, and for those who already profess Him to seek His presence in prayer and His counsel and truth found in the scriptures.**

*For there is no difference between Jew and Gentile—the same Lord is Lord of all and richly blesses all who call on him, for, “Everyone who calls on the name of the Lord will be saved.” (Rom 10:12,13)*

*Let us draw near to God with a sincere heart and with the full assurance that faith brings, having our hearts sprinkled to cleanse us from a guilty conscience and having our bodies washed with pure water. (Heb 10:22)*



**Pray that no bribery or political affiliations of any kind would prevail over true justice.**

*He told them, “Consider carefully what you do, because you are not judging for mere mortals but for the Lord, who is with you whenever you give a verdict. Now let the fear of the Lord be on you. Judge carefully, for with the Lord our God there is no injustice or partiality or bribery.” (2 Chr 19:6,7)*

*You must never twist justice or show partiality. Never accept a bribe, for bribes blind the eyes of the wise and corrupt the decisions of the godly. (Dt 16:19)*

**Pray for them to receive dreams and visions.**

*For God does speak—now one way, now another— though no one perceives it. In a dream, in a vision of the night, when deep sleep falls on people as they slumber in their beds, he may speak in their ears and terrify them with warnings, to turn them from wrongdoing and keep them from pride, to preserve them from the pit, their lives from perishing by the sword. (Job 33:15-18)*



**Pray for wisdom and discernment for each Justice as they rule on the critical issue of life and death for the preborn.**

*I keep asking that the God of our Lord Jesus Christ, the glorious Father, may give you the Spirit of wisdom and revelation, so that you may know him better. (Eph 1:17)*

*But the wisdom that comes from heaven is first of all pure; then peace-loving, considerate, submissive, full of mercy and good fruit, impartial and sincere. (Jas 3:17)*

## Praying for the Law Clerks

**Pray for the salvation of the clerks and a fear of God in their lives.**

*The fear of the Lord is the beginning of wisdom; all who follow his precepts have good understanding. (Ps 111:10)*



**Pray for the clerks who profess Jesus Christ to serve with integrity.**

Show yourself in all respects to be a model of good works, and in your teaching show integrity, dignity. (Tm 2:7)

**Pray they would not compromise or give into pressure to pervert justice.**

*You must not follow the crowd in doing wrong. When you are called to testify in a dispute, do not be swayed by the crowd to twist justice. (Ex 23:2)*

**Pray for the clerks to use their influence for righteousness.**

*To do righteousness and justice is more acceptable to the Lord than sacrifice. (Prv 21:3)*

**Pray for them to seek God's wisdom as they are preparing and assisting the justices.**

*For the Lord grants wisdom! From his mouth comes knowledge and understanding. He grants a treasure of common sense to the honest. He is a shield to those who walk with integrity. He guards the paths of the just and protects those who are faithful to him. (Prv 2:6-8)*



Lord, we lift up these clerks to You by name. We ask that for those who do not know You as Lord and Savior, that they would receive You. We pray that as they are assisting the justices, they would experience the fear of God in their own lives. Open their eyes to see the sanctity of life. Speak to them through dreams, visions, and warnings. We pray for their families, friends, and anyone they are connected to—surround them with godly influences and give sound biblical counsel. Give them courage not to bow down to fear or pressure coming from the world. In Jesus' name, amen.
